### **CALL FOR NOMINATIONS/ APPLICATIONS FOR APPOINTMENT AS NON-EXECUTIVE DIRECTORS ON THE BOARD OF DIRECTORS OF ALFRED NZO DEVELOPMENT AGENCY (PROPRIETARY) LIMITED**

In compliance with provisions of the Local Government; Municipal Systems Amendment Act, Act No, 32 of 2000, Alfred Nzo District Municipality, as parent of Alfred Nzo Development Agency (Proprietary) Limited (“the Development Agency”), a wholly-owned municipal entity and special purpose vehicle, hereby invites nominations/applications from persons who would be suitable candidates for appointment as non-executive Directors on the Board of Directors of the Development Agency.

The Development Agency is a municipal entity established as a special purpose vehicle for the objective of driving and facilitating economic development and investment throughout the Alfred Nzo District. The Board serves as the Accounting Authority of the Development Agency, and will, among others, provide guidance to the Chief Executive Officer regarding the effective exercise of the mandate and functions of the Development Agency.

Candidates should be South African citizens and have a qualification or equivalent, expertise and experience in one or more, of the following fields: Accounting, Business Administration, Economics, Development Finance, Engineering, Finance, Law, and Strategy. It is anticipated that 2-3 members of the Board shall be professionals registered with bodies such as SAICA as Chartered Accountant, the SA Law Societies as attorney, and with SAICCE as Engineer, as well as other bodies.

A written acceptance by the nominee must accompany each nomination, and each nominee must also certify that he or she is not disqualified to serve as a member of the Board. Nominations/applications must be accompanied by letter of motivation, a comprehensive CV and certified copies of qualifications. Please note that the municipality reserves the right to appoint any individual as it deems
