- The bid will be evaluated according to the preferential procurement model in the Preferential Procurement the bidders' attention is drawn to Form MBD6.1. **Failure to submit will result in zero points score for BBBEE status level**
- The Alfred Nzo District Municipality is not bound to accept the lowest or any bidder.
- Bids received after the published closing date will not be considered and will not be opened
- **All bidders should complete MBD 4, MBD 8, MBD 9, MBD 6.2 and Ethics Commitment For Suppliers Of Alfred Nzo District Municipality**


