**OBJECTIVES AND SCOPE OF THE PROJECT**

The ANDM aims at procuring the services of a service provider who will do the training on environmental health law services

- ✓ Law enforcement – preparing for successful prosecution
- ✓ Law enforcement – General enforcement policy for environmental Health
- ✓ Law enforcement – education prior to prosecution

- Suppliers are expected to deliver within 14 days for any goods/services.

**Notes to Prospective Bidders: Compulsory submissions (Failure to submit any of the following will result in disqualification)**

- All bids submitted should remain valid for a period of 90 days after the bid closing date.
- Valid SARS pin number confirmation certificate

- Municipal clearance certificate certifying that no municipal rates and service charges owed by the bidder and any of its directors to Alfred Nzo District Municipality or to any other municipality where the bidder's business operations are located are in arrears for more than three months.
- Certified copies of BBBEE certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor or a Sworn Affidavit.
- **Copies of ID documents and all submitted certificates must be certified**
- The bid will be evaluated according to the preferential procurement model in the Preferential Procurement the bidders' attention is drawn to Form MBD6.1. **Failure to submit will result in zero points score for BBBEE status level**
- Joint Venture agreement (where applicable).
- Bids received after the published closing date will not be considered and will not be opened
- **All bidders should complete MBD1, MBD 4, MBD 8 and MBD 9 and ethics commitment for suppliers or Constructors of Alfred Nzo District Municipality.**
- **Assessment bidder form should be completed and stamped by previous employer and attached with tender submission.**
- All prospective service providers of goods and services and infrastructure procurement are to be registered on Central Database in order to business with all organs of state in the Republic of South Africa.

#### Evaluation criteria of the tenders

The bids will be evaluated in two stages, namely:

- Stage 1- Functionality
- Stage 2- Price and BBBEE Points

Only Bidders who score 0% or more on stage 1 would be evaluated further and therefore eligible for the award.
