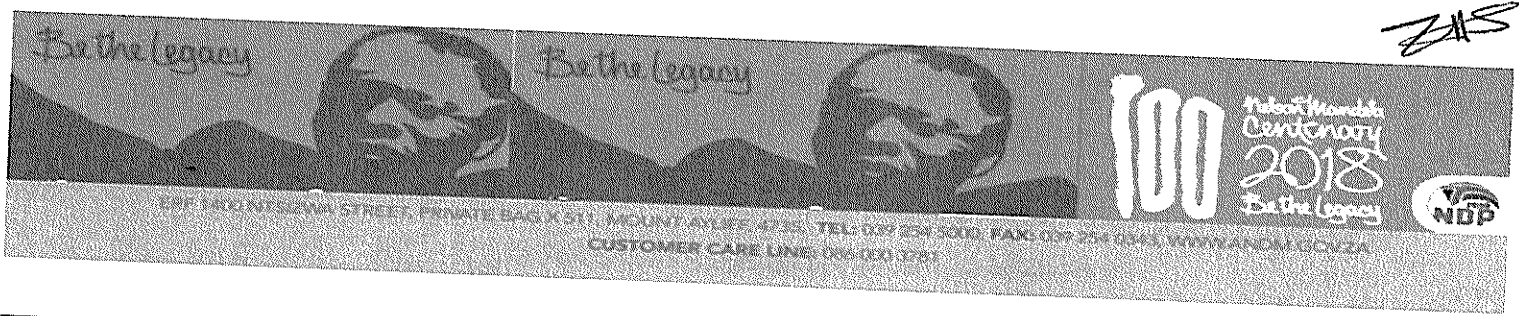

- Construction of the new pond to increase the storage.
- Any appropriate intervention that involves repairs or re-commission dysfunctional existing infrastructure
- Refurbishment of pre-fabricated structure for office, security guard room and toilets ablution.

- **All bidders should be registered with CIDB, minimum of 2CE PE or Higher is required**
- Certified copies of BBEE certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor or a Sworn Affidavit.
- **Copies of ID Documents and all submitted certificates must be certified**

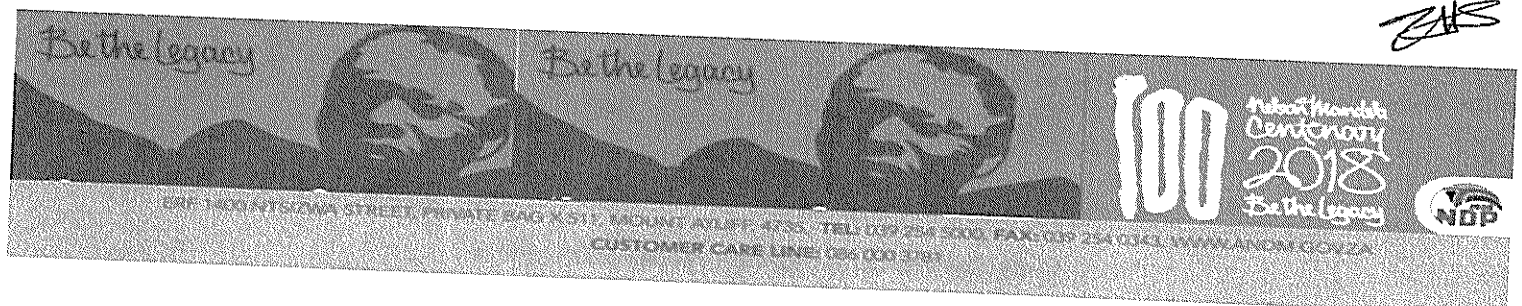

- Company profile with traceable references
- Joint Venture agreement should be in CIDB JV agreement format.
- Letter of good standing from the Bank for all the tender price below R10 million
- The Alfred Nzo District Municipality is not bound to accept the lowest or any bidder.
- Latest Audited Financial Statements for any tender price over R10 million
- Bidders are required to submit Proposed Project Team, their CV's and qualifications.
- **All bidders should complete MBD 1, MBD 4, MBD 8, MBD9 and Ethics Commitment For Suppliers Of Alfred Nzo District Municipality**
- **Assessment bidder form should be completed and stamped by previous employer and attached with tender submission.**
- All prospective service providers of goods and services and infrastructure procurement are to be registered on Central Database in order to business with all organs of state in the Republic of South Africa.

**Failure to supply all required and supplementary information will result in the tender being deemed non-responsive; and therefore the tender will not be considered for award.**

#### Evaluation Criteria

The bids will be evaluated on the basis of the Preferential Procurement Policy Framework Act (Act No.5, 2000), and the regulations pertaining thereto (2011), as well as the Alfred Nzo District Municipality's Supply Chain Management policy.80/20 preference point system will be used as per the ANDM SCM Policy.


