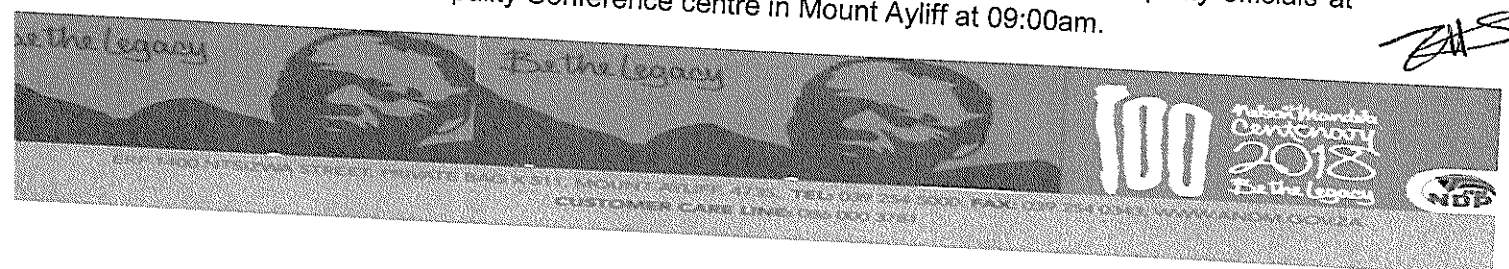

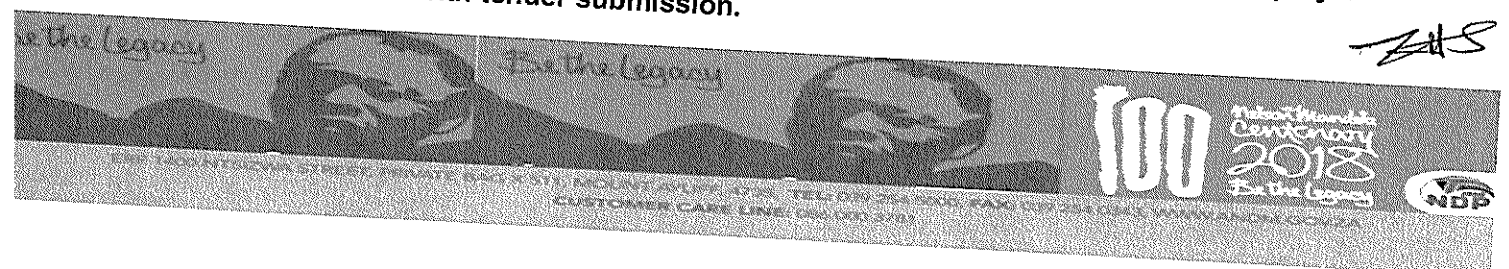

- Manzi Amnyama: Supply and installation of 60KL Galaxy reservoir wall with 65mm scour valve, outlet valve with 65mm Spindle isolation valve and 50mm air valve. All valves to be housed in 1000 x 1000 x 750mm brick chamber with concrete cover.
- Ntshamanzi: Supply and installation of 40KL Galaxy reservoir wall with 65mm scour valve, outlet valve with 65mm Spindle isolation valve and 50mm air valve. All valves to be housed in 1000 x 1000 x 750mm brick chamber with concrete cover.

## Notes to Prospective Bidders: Compulsory submissions (Failure to submit any of the following will result in disqualification)

- Municipal clearance certificate certifying that no municipal rates and service charges owed by the bidder and any of its directors to Alfred Nzo District Municipality or to any other municipality where the bidder's business operations are located are in arrears for more than three months
- Valid SARS pin number confirmation certificate
- **All bidders should be registered with CIDB, minimum of 2CE PE or Higher is required**
- Certified copies of BBBEE certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor or a Sworn Affidavit.
- **Copies of ID Documents and all submitted certificates must be certified**
- The bid will be evaluated according to the preferential procurement model in the Preferential Procurement the bidders' attention is drawn to Form MBD6.1. **Failure to submit will result in zero points score for BBBEE status level**
- Company profile with traceable references
- Joint Venture agreement should be in CIDB JV agreement format.
- Letter of good standing from the Bank for all the tender price below R10 million
- The Alfred Nzo District Municipality is not bound to accept the lowest or any bidder.
- Bidders are required to submit Proposed Project Team, their CV's and qualifications.
- **All bidders should complete MBD 1, MBD 4, MBD 8, MBD9 and Ethics Commitment For Suppliers Of Alfred Nzo District Municipality**
- **Assessment bidder form should be completed and stamped by previous employer and attached with tender submission.**

### Evaluation Criteria

The bids will be evaluated on the basis of the Preferential Procurement Policy Framework Act (Act No.5, 2000), and the regulations pertaining thereto (2011), as well as the Alfred Nzo District Municipality's Supply Chain Management policy.80/20 preference point system will be used as per the ANDM SCM Policy.

Received Responsive bids will be evaluated based on the following criteria:

- Stage 1 – Functionality
- Stage 2 – Price and Preferential Points

Only bidder scored a minimum of 70 out of 100 points will be considered for a Stage 2 evaluations.


### **BID CLOSING DATE**
