• Certified copies of BBEE certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor or a Sworn Affidavit- Failure to submit will result in zero points score for BBEE status level.

- Copies of ID Documents, CK and all submitted certificates and CK must be certified
- The bid will be evaluated according to the preferential procurement model in the Preferential Procurement the bidders' attention is drawn to Form MBD6.1. The Alfred Nzo District Municipality is not bound to accept the lowest or any bidder.
