- Registered Auditor or a Sworn Affidavit- Failure to submit will result in zero points score for BBBEE status level.
- Copies of ID Documents, CK and all submitted certificates and CK must be certified
- The bid will be evaluated according to the preferential procurement model in the Preferential Procurement the bidders' attention is drawn to Form MBD6.1. The Alfred Nzo District Municipality is not bound to accept the lowest or any bidder.
- Quotation received after the published closing date will not be considered and will not be opened.
- All bidders should complete MBD 4, MBD 6.2 (Local Content), MBD 8,MBD 9 and Ethics
